2. To maintain the building sewer at no expense to the Authority.
3. To notify the Authority **twenty-four (24)** hours in advance when the building sewer is ready for inspection and connection to the public sewer, but before any portion of the work is covered.
4. **This permit will be null and void 12 months from issue date if inspection and connection have not been made during the 12-month period.**
5. Installer shall field verify all measurements for the sewer lateral from the building drain to the lateral connection point, including the depth of the lateral line to the sewer line. All information received from the Authority is advisory only and must not be relied upon.
